To manage the works/projects undertaken by the Dera Santpura Jabbar, Sant Baba Malkit Singh Ji persuaded the general public, NRIs and other well-wishers of the Dera to form 'Sant Baba Bhag Singh Memorial Charitable Society (SBBSMCS)' in the year 2000 & guided all concerned towards "Self-Help Movement" with a mission to uplift the 'Rural Education & Rural Health Care' alongwith the development of Infrastructure in this rural area. In this process, many important projects i.e. Construction & maintenance of Roads, Bridges, Dispensaries, Provision of street lights, Addition of Classrooms, Laboratories, auditorium etc. in the many Government and Private Schools were undertaken in this rural, backward & flood ravaged area under the guidance of Sant Baba Malkit Singh Ji. The projects were completed in record time by motivating the public and mobilizing its own resources without any help from any Govt. agency. Approximately Rs. 20 Crores were spent on above said development projects.

To uplift the Rural Education Level, SBBSMCS established 'Sant Baba Bhag Singh Educational Complex (SBBSEC)' in year 2003 by offering education in the field of Engineering, Management, Education, Nursing, Schooling etc.

Establishment of Sant Baba Bhag Singh University: -

Sant Baba Bhag Singh Educational Complex has been given the Status of Sant Baba Bhag Singh University (Established vide "The Sant Baba Bhag Singh University Act, 2014 (Punjab Act No. 6 of 2015) & included in the UGC List of Universities".

ABOUT SANT BABA BHAG SINGH UNIVERSITY

Sant Baba Bhag Singh University came into existence vide Sant Baba Bhag Singh University Act, 2014 (Punjab Government Act No. 6 of 2015) and has been duly included in UGC List of Universities. This University has been created in the name of Sant Baba Bhag Singh Ji, who carried forward the mission of 'NIRMALA PANTH' initiated by Sri Guru Gobind Singh Ji, the Tenth Guru of Sikhs, to spread education for all round development of the society. Sant Baba Bhag Singh Ji visualized that education and self help are the transforming forces for upliftment of the common man. To achieve this, Sant Baba Malkit Singh Ji adopted flash rivulet devastated rural area of Jabbar/Manko (Jalandhar) and marched on to educate people to identify their problems and then solve it by self help. In this direction, a programme of 'Girl Education' was initiated in 1954 with a view that girl education was a step towards empowerment of the family. Carrying forward the legacy, Sant Baba Malkit Singh Ji established Sant Baba Bhag Singh Memorial Charitable Society (SBBSMCS) in the year 2000, facilitating education from Nursery to Postgraduate Degree level, to make Quality Education accessible to rural youth in technical and professional streams in the Doaba region of Punjab.

LATERAL ENTRY TO SECOND YEAR TO ENGINEERING AND TECHNOLOGY

Engineering and Technology

- A. Passed Diploma examination from an AICTE approved Institution, with at least 45% marks (40% in case of candidates belonging to reserved category) in appropriate branch of Engineering / Technology.
- B. Passed B.Sc. Degree from a recognized University as defined by UGC, with at least 45% marks (40% in case of candidates belonging to reserved category) and passed XII standard with mathematics as a subject.
- C. Provided that in case of students belonging to B.Sc. Stream, shall clear the subjects of Engineering Graphics / Engineering Drawing and Engineering Mechanics of the first year Engineering program along with the second year subjects.
- D. Provided further that students, who have passed Diploma in Engineering and Technology from an AICTE approved Institution or B. Sc (Non-Med) Degree from a recognized University as defined by UGC, shall also be eligible for admission to the first year Engineering Degree courses subject to vacancies at lateral entry are exhausted. However the admissions shall be based strictly on the eligibility criteria as mentioned in A, B, C, and D above.

➡ ADVANCE SOFTWARE DEVELOPMENT LAB

Advance software development lab is used for teaching concepts of Database Management System and is equipped with Oracle server. This lab serves as Oracle Academic Initiative Lab.

RESEARCH AND DEVELOPMENT LAB

This lab is established to fulfill the research needs of students & faculty. It is designed as per the requirements of students and team project development of software projects with 3rd generation computer systems.

➡ SOFTWARE LAB-I

This lab is for teaching programming languages C, C++, Visual C++, C# along with design and analysis. The students also has facility to familiarize with HTML, DHTML and programming concepts.

➡ SOFTWARE LAB-II

The students familiarize themselves with the techniques to implement, evaluate and analyze the concepts of Data Structure, Programming Methodologies, Expert System, Windows Programming, Computer Graphics Programming and Tools.

SOFTWARE LAB-III

Software Lab-III serves all first year students of all engineering branches. The lab has Latest Configuration PC's with software which are of learning needs of students i.e. C++, Microsoft-Office, Operating System, Windows.

SOFTWARE LAB-IV

This lab is set up to provide learning environment for courses in E-Commerce, .NET & Java. It helps the students to sharpen their skills to be competitive in industry.

➡ HARDWARE LAB

This lab facilitates learning of Data Communication & Computer Networks. It also give opportunity of hands on experience in computer hardware and to enlighten their knowledge for computer components.

SOFTWARE ANALYSIS LAB-I

This lab has internet facility for all students of university to help them to develop projects and test them.

SOFTWARE ANALYSIS LAB-II

This lab supplements the development of software projects.



CENTRAL LIBRARY

SBBS University has a Central Library and its branches in University Institutes. It serves as a central service unit to facilitate help in creation of new knowledge through acquisition, organization and dissemination of information. The Library offers a wide range of materials in a variety of formats i.e. from traditional books and serials to e-books and networked information covering all disciplines of Science, Engineering, Technology, Humanities, Management, Nursing, Education, Spiritualism and many more in Open Access System. Apart from acquisitioned books, periodicals, theses and project reports, library user has access to more than 10,000 electronic journals and about 1.00 Lac E-books in its digital library section. The University has subscribed DELNET service through this library to have access to major online databases and documents viz. Union Catalogue of Books and e-Books, Union List of Article Database and e-Journals in addition to Document Delivery Service. Our Library has mutual relations with other major libraries for resource sharing. The library is digitized. It has its own computer section for access to digital resources such as on line journals, books and other digital information resources. On-line Public Access Catalogue (OPAC) is available to know the status of books in the library. Skilled staff assists to use the resources and retrieve information on specific topics. Our library is a learning space where faculty, research scholars and students are motivated to explore, acquire and create information. Library also extends apprenticeship to the students of librarianship to have working experience using Library Management Software.



TRANSPORT FACILITY

The college has a fleet of 51 Buses plying from various cities/ locations e.g. Guraya, Phagwara, Jalandhar, Hoshiarpur, Dasuya, Mukerian, Bhogpur, Garhdiwala, Allawalpur, and Mahilpur. Additional buses to any other city/location can be arranged if it is financially viable.



DEPARTMENT OF TRAINING & PLACEMENT

Training & Placement department is in contact with more than 300 companies (e.g. HCL, Infosys, Sonalika, Anand Group of Companies, Kirloskar, L & T, Birla Copper, Accenture, BSNL, Enercon India, Philips, Era Group, Kaynes Technologies, Sigma Freudenberg, Syntel, Sasken, India Mart, Dish TV, etc.) for Industrial Training & Placements. Students have also been selected for Defence Forces, under UES scheme. The placement record of 2015 batch shows that about 70% of eligible students have already been placed. The facilities for recreation, indoor games, guest rooms, telephone, 24 X 7 water / electricity supply and medical facilities are available in the hostels. A central totally hygienic kitchen/mess for hostels has been established in each hostel.

12 Mbps Wi-Fi facility is available in hostel. Gym facility is available in hostel.

MEDICAL FACILITIES

A central dispensary has been established to provide the first aid in case of any medical problem. An Ambulance is also available in the campus to take the student to Guru Nanak Sadh Sangat Charitable Hospital, Kalra in case of emergency medical case.

RULES & REGULATIONS OF SBBSU

A. GENERAL RULES

- A student shall confirm to high standards of discipline and shall conduct himself/herself, within and outside the premises of the University, in a manner befitting the students and the University.
- He/She shall have a seriousness of purpose and shall in every way train himself/herself to lead a life of earnest endeavor and co-operation.
- He/She shall show due courtesy and consideration to the Employees of the University and good neighborliness to his fellow students, respect to the wardens of the hostel and the teachers of the University and pay due attention and courtesy to the visitors & members of Society and other officials of University.
- Ragging in any form is banned. Ragging is a criminal offence as per the Supreme Court ruling and FIR shall be registered against the student(s) found indulging in the crime.
- To safeguard its ideals, character and personal behavior, University reserves the right to expel the students from the institution for any reason deemed sufficient.
- The Head of Department (HoD) can impose minor punishment such as fine up to Rs. 500/-.
- HOD can place a student under suspension from class/Hostel in case of gross indiscipline on the part of student.
- Major punishment such as expulsion/rustication from the University, debarring the candidate from appearing in the university examination shall be executed by Principal on the result of enquiry conducted by disciplinary committee.
- Students and their parents/representatives are forbidden from addressing members of SBBSMCS Authorities.
- Consumption of non-vegetarian food, alcohol or any other intoxicant and smoking, etc, are strictly prohibited in the University Campus.
- The guilty students shall be liable for punishment and disciplinary action which may include suspension, expulsion from the University or hostel or imposition of fine or both.
- Semester tuition fee and fine imposed, if any, is to be deposited in time, failing to do so may lead to suspension from classes/debarring from appearing in examination.
- All kinds of shouting or any act of movement or behavior that is likely to cause disturbance of the teaching is strictly prohibited.

- Every student is to see that no damage is done to University property. Fitting and repair charges for the damage [intentional or negligence] are to be borne by the student.
- 15. Regarding college bus facility to day scholars, minimum 3 months fee will be charged from the student if he/she discontinues availing the facility before mid-session or starts availing the facility after mid-session. Similarly full six months fee will be charged if he discontinues availing the facility after mid-session or starts availing the renewal facility before mid-session.
- The University reserves the right to make amendments in these rules & regulations from time to time.
- Eligible SC, ST, BC, OBC, PWD students etc. should submittheir scholarship forms for the academic year by August.

ACCESS TO LIBRARY RESOURCES AND COMPUTER BASED

SERVICES: Readers have free access to books and periodicals displayed on open shelves. Reference books, Theses and Project Reports can be consulted only in the assigned area. Online Public Access Catalogue and computer based library services are available free of cost to staff and students of Sant Baba Bhag Singh Educational Complex including SBBS University. Library Members are free to seek assistance of library staff in selecting reading material, checking of references, and searching of misplaced reading material etc.

E-LIBRARY SERVICES: Library subscribes to DELNET (Developing Library Network) to get access to major online databases and documents covering Education, Engineering & Technology, Management, Pharmacy etc in addition to Document Delivery Services. Apart of this, the library also facilitates access to more than 10,000 high quality Open Access Peer-Reviewed Journals; Full-Text Electronic Theses

and Dissertations submitted to various Indian Universities and Institutes and about 1.00 Lac high quality e-books previously published by bonafide publishers.

INTER LIBRARY LOAN: Books and Periodicals not available in the library can be requested on loan from other University/Institution Libraries. The cost of postage on them has to be paid by the member for whom these are borrowed on Inter Library Loan.

MEMBERSHIP: Library members enjoy the privilege of borrowing books. The Students and Employees of SBBSU / SBBSEC can enroll themselves as members by filling a prescribed application form and agreeing to abide by the rules. Others can use the library material only with special permission of Librarian. Borrower's cards, given to registered members are strictly non transferable and are to be renewed every year.

Anyone found creating indiscipline in the library or misbehaving with the library staff will be debarred from the library for the next fifteen days and in serious cases membership will be cancelled and disciplinary action will be taken. Students or any other person found taking books out of the library without authorization will be punished with a heavy fine and disciplinary action will be initiated.

LOAN PRIVILEGES: Normal check-out/check-in of library reading material is suspended half an hour before closing of Circulation Counter. On 1" & 3" Saturday, Sunday and holiday, there is no check out and check in of library reading material. Reading material can be loaned out to the departments for its consultation and reference. The Librarian can recall any library reading material at any time if necessity arises. The number of books, a borrower can take except dissertation/thesis/project report, and the period for which one can retain them is as follows:

As a special case, Periodicals/Reference Books will be issued for overnight only.

Documents borrowed for overnight must be returned within an hour of the opening of library on the next working day.

OVERDUE CHARGES: Following overdue charges are recovered for library material retained longer than the period of loan from all borrowers:

General book Rs. 2.00 per day per document Overnight Book/Periodical Rs. 2.00 per hour per document Note: Fine can be reduced or remitted by the Librarian on reasonable grounds

LOSS OF LIBRARY MATERIAL: The following charges are

recovered for the loss of library material:

I. BOOK: Replacement or the current price plus Rs. 100/- as processing and binding charges. The cost of complete set may have to be paid for the loss of a single volume if it is not published separately. In case current price of lost book is not available, the price to be charged from the reader will be @ 10% increase in price every year from the date of its procurement subject to the maximum of five times of its original price. However, the reader is at liberty to replace new copy of the same or better edition of lost book. In case of books whose price is not given in the accession record or not available in any catalogue available in the library, the Librarian is authorized to fix reasonable price.

II. PERIODICAL

a. SINGLE ISSUE OF PERIODICAL:

Replacement within three months or the cost of the volume if the single issue is not available.

b. BOUND VOLUME OF PERIODICAL:

Replacement for the volume or four times the cost of volume plus Rs. 200/- as processing and binding charges.

III. LOSS OF LIBRARY MEMBERSHIP CARD: In case library membership card is lost or misplaced, a new card is issued on payment of Rs.200/- . Loss of membership card should be reported immediately at the circulation counter. However, the member still remains responsible for the documents(s) issued. REPROGRAPHICS SERVICES: Photostat service is available to the readers of library @ Re. 1.00 per exposure per copy.

- Always bring library card while visiting the library. Visitor without Library Card/ Identity Card may be asked to leave the library.
- No one is allowed to take his/her personal books inside the library.
- Particulars of your personal Laptops and other computer peripherals should be recorded at the Gate Counter.
- Keep all belongings like personal books & other printed material, umbrella, bags files etc. at the Property Rack, place outside of the library.
- The "No Dues Certificate" can be secured from the library after surrendering library card and clearing all library dues
- No library reading material would be considered returned until it has been returned properly to the person at the circulation counter.
- Taking books out of the library without authorization, marking or underlining or in any way disfiguring and mutilating books or library property is a misdemeanor which may lead to withdrawal of library privileges or in serious cases to heavy fine and disciplinary action. Library is yours, love it and do not mutilate books. Books are for the generations to come.
- At the time of issue, the borrower should check condition

of the book to be issued. In case it is damaged or not in good condition, it should be pointed out to the library officials at the Circulation Counter otherwise last borrower shall be responsible for any damage to the book/periodical etc.

- Get yourself checked at exit while you go outside.
- Eating/Drinking in the library premises is strictly prohibited to keep away ants, flies, and other insects etc.
- Maintain PIN DROP SILENCE in and around the Library premises.

SUGGESTION BOX: Members are free to recommend new books or journals for the library and to suggest improvement in library services by dropping suggestions in the Suggestion Box placed near the Circulation Desk.

C. IDENTITY CARD RULES

- Every student is supposed to get plastic laminated identity card. In this connection a notice will be issued from the office regarding authorized Photographer.
- The photographer will be available in the University on the specified dates and timings.
- Every student must be in possession of identity card with him/her while in the classes or University premises.
- Failure to produce the identity card on demand of the competent authority will lead to disciplinary action/imposition of fine.
- Loss of identity card must be reported to Head of Department or Dean immediately and a new card be obtained within a week.
- 6. The fee for the replacement will be Rs.100/-

D. ATTENDANCE RULES

- A student must be regular and punctual in attendance.
- If a student remains absent from the University continuously for ten days, his/her name will be struck off in University rolls.
- He/She may be re-admitted on the payment of readmission fee and penalty. He/She will not be allowed to attend the class till he/she is readmitted.
- 4. A student must fulfill the requirement of attendance as laid down by the university, minimum 75% attendance is mandatory, failing which, he/she will be detained from appearing in the university examinations.

E. LEAVE RULES (University)

 Normally a student is expected to attend all classes.
 Absence from classes without valid reason is an act of indiscipline. It is mandatory for a student to have 75%

- attendance of scheduled classes for appearing in University examination.
- Students absenting themselves without valid reason shall be liable to disciplinary action including fine.
- 3. The medical officer must recommend leave application on medical ground. Father/Guardian of student must countersign such application before it is sent to the University. Medical officer will clearly specify the disease and the period of rest recommended. Medical Certificate from the competent authority must be submitted on rejoining the University.
- 4. The Dean will sanction medical leave.
- Absence from examination for whatever reason will not make the student eligible for any benefit.
- Students intending to go outside the campus gate during working hours can do so with the permission of HOD.
- No Leave shall be counted towards making up of 75% attendance.

F. EXAMINATION RULES (Internal)

- There shall be two examination during the semester, followed by end of semester examination.
- It is compulsory for the students to appear in all the examinations.
- In case a student falls ill during the course of examination, his/her leave application on the prescribed form supported by the medical certificate should be submitted immediately.
- Theory and practical in each subject are considered two separate units.
- A student found guilty of using unfair means during the examination will be given deterrent punishment. He/She may even be expelled from the University or disqualified from appearing in the university examination.
- No leave application will be accepted at a later date after the terminal examination.

G. HOSTEL ACCOMMODATION

- Separate boys & girls hostels are available. The hostel rooms are fully equipped with adequate modern furniture & fixtures. The mattresses and bedding are provided by the University. The bed sheets are regularly washed free of any cost by the person(s) hired by this University.
- 2. The facilities for recreation, indoor games, guest

rooms, telephone, 24 X 7 water / electricity supply and medical facilities are available in the hostels. A central totally hygienic kitchen/mess for hostels has been established in each hostel.

- 3. 12 Mbps Wi-Fi facility is available in hostel.
- 4. Gym facility is available in hostel.

H. HOSTEL ROOM ALLOTMENT

- The student must be personally present at the time of allotment of rooms. Rooms to be allotted will be specified immediately before an allotment is made.
- The student can choose their roommates initially and make request for allotment accordingly.
- The boarder shall not be entitled to retain accommodation in the Hostel beyond his/her normal period of study.
- No boarder is allowed to change his/her room without the permission of the Warden.
- The boarder shall have to vacate accommodation as and when asked for.

I. FURNITURE AND EQUIPMENT (HOSTEL)

- Every boarder is provided with a chair, a table, a cot, a Book rack, a Cupboard and bedding. He/She will be responsible for these items and other electrical fittings, etc. Furniture and electrical fittings are not to be removed from one room to another. Every boarder is to see that no damage is done to the hostel property.
- Fitting & repair charges for any damage (intentional or negligence) are to be borne by the boarder concerned.
- Use of all electric appliances, except laptop, mobile charger and an extra table lamp, is prohibited.

J. HOSTEL RULES (GENERAL)

- 1. The hostel accommodation shall be provided to the regular students, if available. The students who can make suitable arrangement with their parents or guardians for boarding & lodging outside the campus may be allowed to do so with the permission of the Dean, Students Welfare, on production of a written undertaking from the parents / guardian that they will take part in all extracurricular activities of the University and shall exhibit good conduct.
- Every Boarder must have a copy of the rules to acquaint himself with the rules and regulations of the Hostel. He/She must observe them strictly. Ignorance of rules will not be considered as an excuse.
- 3. While issuing character certificate to the boarders, the

- opinion of the Hostel Warden will be given weightage.

 The Hostel warden will exercise general supervision and control over the hostellers.
- Boarders must look up the Hostel Notice Board twice a day, as important notices are put up there.
- For all ordinary and routine matters, the hostellers should contact the Hostel Warden only. The Hostel Warden shall take up the matters beyond his powers to the next higher authority as deemed appropriate.
- All cases of illness should be reported to the Hostel Warden.
- 7. No Student should keep any fire-arms, lethal weapons, sharp edged weapons, poisonous things or intoxicants of any kind in the Hostel and a boarder found guilty of having committed a breach of this rule, 'shall be liable to be expelled from the hostel, apart from any other punishment that may be awarded on the merit of each case, by the Dean, Students Welfare, of the University.
- Any meeting to be held in the Hostel premises should have the prior approval of the Hostel Warden.
- 9. The students shall make proper use of common rooms having newspapers, allied literature and other articles required for indoor games. Hours of the common room will be fixed by the Hostel Warden from time to time. The common room Secretary and Jt. Secretary will be responsible for running the common room. The Secretary/ Jt. Secretary shall be nominated by the Warden in the first instance.
- While visiting the dining hall, the common room and canteen, the students should be in their proper dress.
- On each floor of the hostel, a student amongst the boarders shall be appointed as Prefect for that floor. He will assist the Hostel Warden in the administration of the Hostel affairs.
- 12. All the boarders shall vacate the hostel rooms before they leave for the vacation so that necessary repairs and white washing are carried out. All the hostel articles issued to the students need be returned to the Hostel Warden/Clerk before the students leave their rooms. They will be responsible for any loss. The loss if any will be made good from the defaulters.
- The mess arrangement will be under the direction of the warden and for his assistance there will be a mess committee.
- 14. The Dean, Students Welfare, with the concurrence of

the Vice-Chancellor, shall have the power to make amendment in the Hostel Rules from time to time.

K. LEAVING & EXPULSION RULES FROM THE UNIVERSITY HOSTEL

- After the general allotment, application for withdrawal from the hostel should be counter-signed by the father/guardian and submitted to the Hostel Warden.
 Such an application should be presented after hostel dues have been cleared.
- Even if the boarder has actually vacated his/her room, he/she will have to pay all the hostel dues and fines standing against his/her name up to the day he/she continues to be on rolls, until his/her name is formally withdrawn.
- A boarder may be expelled from the hostel by the Dean, Students Welfare, if the boarder is in the habit of staying away without the permission and hostel fee and mess dues are in arrears for more than a month.
- 4. Students who do not clear their dues such as dues of the hostel mess, canteen, fine, etc. by the prescribed date will not be registered for the subsequent semester until and unless, they clear all their dues and get "No dues certificate" from the Registrar and the concerned Hostel Warden. In case of those students who are to leave the University after completing the degree requirements or otherwise, their result as well as the Provisional Certificate/degree will be with-held till NO DUE certificates is produced.
- 5. No boarder shall leave the hostel without personally handing over the charge of the room. Loss, if any, will be recovered from him/her. He/she should get the hostel leaving slip from the hostel warden/ clerk.
- 6. Minimum 3 months fee will be charged from the student if he/she leaves the hostel before mid-session or join the hostel after mid-session. Similarly full six months fee will be charged if he leaves the hostel after mid-session or join the hostel before mid-session.

L. LEAVE RULES (Hostel)

- From Monday to Thursday hostellers are not allowed to leave the hostel for one or more nights without the permission of HOD & Chief Warden of hostels.
- 2. On last working day of the week male students can leave for their weekends by noting down in the register meant for this purpose. However female students must intimate in writing to the warden their intention of availing leave from hostel during weekends. Anyone

- not returning on next working day will be fined.
- Students absenting themselves from the hostel without getting the prior sanction of the leave shall be penalized.

M. NIGHT ROLL CALL

Boys Hostel

- During winter no student is allowed to go out of the complex after 6.00 pm. All students must return to the complex by 7.00 pm.
- During summer no student is allowed to go out of the complex after 7.00 pm. All students must return to the complex by 8.00 pm.
- Night roll call will be taken between 7.00 pm to 9.00 pm.

Girls Hostel

- No girl student staying in hostel will remain outside the hostel after 8.00 pm both in summer and in winter.
- Night roll call will be taken between 6.00 pm to 7.00 pm.
- All girls must report to the warden during this time for marking the attendance.

N. GUESTS

- 1. Guests are not, ordinarily, permitted to stay in the hostel except in the case of father / brother & mother/sister (in case of girl students) provided he/she comes from a far off place at odd hours. The student must get permission for keeping his/her guest in the hostel from the Chief Warden. The guests so allowed will be kept in the hostel guest-room. Their names will be entered in the guest register kept in the hostel.
- Female guests are not permitted to stay in Boys hostel.
 Likewise male guests are not allowed to stay in the girl's hostel. A boarder keeping a guest without permission is liable for punishment.

O. ELECTRICITY

- Light, fans & coolers must be switched off when not in use.
- The use of electric heater, electric rod, electric tea kettle, etc. and other similar appliances is prohibited.
- Boarders are warned against tampering with electrical installation. For all electrical repairs the electrician should be called in.

P. BEHAVIOUR AND DISCIPLINE

1. Hostellers are expected to display acceptable form of

- behaviour, maintain discipline and decorum in the hostel complex.
- Possession, distribution and consumption of alcoholic beverages, prohibited drugs, chewable tobacco and smoking in the hostel complex is not allowed.
- Parties/Gathering in hostel complex are not permitted without the prior and written consent of the chief warden.
- Hostellers must return to the hostel by 6.00 pm in winter and 7.00 pm in summer on off days after vacation or holidays as intimated by authorities.
- The hosteller will be allowed to stay out of hostel on submission of proper application duly authorized by parent and only if the permission is granted in writing by the authorities.
- 6. Hostels should be a place where students can have the best possible conditions for studying and adequate rest. As such due consideration must be accorded to other hostellers at all times. Noise level must be kept low to allow other's opportunity to study and sleep in comfort. Television, Radio etc. provided in the common room must be switched off after 10.00 pm. These rules are intended to ensure a conducive environment for all hostellers. Personal music systems, woofers, etc. are not allowed. Students may listen to music by using earphones.
- Vandalism is very serious offence. Hostellers found guilty of committing such an offence can be evicted from the hostel and penalized.
- In case of any unacceptable behaviour by the roommate, the other room-mate must report it to the college authorities.
- All kinds of shouting or any other act of movement or behaviour that is likely to cause disturbance or annoyance is strictly prohibited.
- Maltreating or showing disrespect to the hostel employees and canteen staff is strictly prohibited. In case of any complaint against them, the report should be made to the Hostel Warden.
- Dealing in general and specially with fellow students should be very courteous and polite. All disputes with fellow boarders should be avoided. Students must not take law into their own hands, but must report all disputes to the Hostel Warden.
- 12. Teasing, maltreating or indulging in any sort of

- RAGGING of the newly admitted students is strictly prohibited. Serious disciplinary action will be taken against the defaulting students in accordance with the directions of the Hon'ble Supreme court of India.
- 13. A boarder found guilty of having committed a breach of rules shall be liable to the punishment by the Warden as under:
 - The Hostel Warden may issue a warning and/or impose fine on a defaulting student and may recommend expulsion from the Hostel/University.
- Rules listed on the wall at the entrance of the hostel must be read and strictly adhered to.

Q. UPKEEP OF THE HOSTEL

- Hostellers are responsible for keeping their rooms clean and help in keeping common areas in the hostel such as visitor's area, bathrooms, stair case and common room etc. clean and tidy at all times.
- All fans, lights and electrical appliances must be switched off when not in use.
- Cooking, making tea, etc. is not allowed in the hostel rooms.
- Common hostel furniture must not be moved without the permission of the chief warden.
- Any damage to the hostel property must be reported immediately to the Warden/Chief Warden. Defaulting hosteller will be charged for all damages except damages caused by normal wear and tear.
- Pasting of posters, writing, wall chalking, slogans of any kind or defacing the hostel in any form is not allowed.
- The hostel management reserves the right to make spot checks during day & night on the hostel and rooms without having to give prior notice to the students.
- 8. Electrician, contractors or any other service person may enter the room as and when necessary in the course of their duty under the directive of the warden/chief warden. However, every effort will be made to respect the privacy and dignity of the hostler.
- The hostel management reserves the right to move hostellers to other hostel room/units if there is a necessity.

R. EMERGENCY

In case of any emergency please contact the Warden/Chief Warden or call hostel / college authorities.

S. MEDICAL

- Hostellers should immediately inform the warden/chief warden in case of any medical problem to get immediate first aid or general medicine from Medical Room.
- Ambulance, if necessary, will also be available to send the student to Guru Nanak Sadh Sangat Hospital, Kalra, on the advice of I/c, Medical Room.

T. SBBSU IS RAGGING FREE CAMPUS

India is struggling to curb and prevent the menace of ragging. Many cases of ragging have been reported over the previous years. It is most satisfying that SBBSEC, established in 2003, is free from ragging.

Every year the authorities take-up a special drive to enlighten the students not to include in ragging under any circumstances. Anti-ragging posters are displayed at all important places in the University and in the Hostels. Letters are dispatched to the parents to advise their wards not to include in ragging.

With a view to check ragging in hostels and campus Anti-Ragging Squads are constituted to curb & prevent any possible instant of ragging. All ragging cases, if any, will be reported by the co-ordinators of the squads to the Anti-Ragging Committee.

The following acts, but not limited to, are regarded as acts of Ragging:

- a) Any conduct by any student or students whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness a fresher or any other student.
- b) Indulging in rowdy or indiscipline activities by any student or students which cause or is likely to cause annoyance, hardship, physical or psychological harm or to raise fear or apprehension thereof in any fresher or any other student.
- c) Asking any student to do any act which such student will not in the ordinary course do and which has the effect of causing or generating a sense of shame, or torment or embarrassment so as to adversely affect the physique or psyche of such fresher or any other student.
- d) Any act by a senior student that prevents, disrupts or disturbs the regular academic activity of any other student or a fresher.
- e) Exploiting the services of a fresher, or any other for completing the academic task assigned to an individual

or a group of students.

- f) Any act of financial extortion or forceful expenditure burden put on a fresher or any other student by the students.
- g) Any act of physical abuse including all variants of it sexual abuse, homosexual assaults, stripping, forcing obscene and lewd acts, gestures, causing bodily harm or any other danger to health or person.
- h) Any act of abuse by spoken words, emails, post, public insults which would also include deriving perverted pleasure, vicarious or sadistic thrill from actively or passively participating in the discomfiture to fresher or any other student.
- Any act that effects the mental health and self confidence of a fresher or any other student with or without an intent to derive a sadistic or showing off power, authority or superiority by a student over any fresher or any other student.
- j) Depending upon the nature and gravity of the offence as established by the anti-ragging committee of the University, the possible punishments for those found guilty of ragging at the institution level shall be anyone or any combination of the following:
 - 1. Cancellation of admission.
 - 2. Suspension from attending classes.
 - Withholding/withdrawing scholarship/fellowship and other benefits.
 - Debarring from appearing in any test/examination or other evaluation process.
 - 5. Withholding results.
 - Debarring from representing the institution in any regional/national or international meet/tournament, youth festival etc.
 - 7. Suspension/expulsion from the hostel.
 - Rustication from the institution for period ranging from one to four semesters.
 - Expulsion from the institution and consequent debarring from admission to any other institution.
 - 10. Fine of Rs. 25,000/-
 - 11. Collective punishment: When the person committing or abetting the crime of ragging is not identified, the institution shall resort to collective punishment as a deterrent to ensure community pressure on the potential raggers.
 - 12. For every incident of ragging the First Information

Report (FIR) will be filed without exception with the police authority.

U. VISITORS

- Visitors including parents are allowed only into the visitors area of the hostel during the visitors hours as follows:
 - a. Weekend (Saturday) 3.00pm to 6.00pm
 - b. Weekend (Sunday) and holidays 9.30am to 4.00pm
- 2. All visitors must register at the guard house/warden office and provide all details and documents as requested by Security before entering the hostel complex. All visitors must leave the hostel complex by the laid down timings.
- Hostellers are not permitted to allow their visitors into rooms at any time for whatever reason. Any hosteller found violating this rule will be evicted from the hostel and penalized.
- Non-hostel students are prohibited in the hostel without the permission of warden. The students who violate this will be answerable to the warden.

V. SECURITY

- The hostel management is not responsible for any loss of private property. Hostellers are strongly advised to lock all their valuable e.g. Mobile Phones, Laptops, Watches, Money, etc. at all times.
- Hostellers are not permitted to change rooms or sleep anywhere other than in their own room.
- 3. Any hosteller, who finds his/her room-mate missing after the roll call, or for more than 12 hours in day time, must report to the Warden/Chief Warden immediately. This enables the hostel authorities to take immediate action. Cooperation of the students will be very much appreciated.
- Possession, distribution and use of Fire Arms, Lethal Weapons including Air Gun, Contraband, Electric Appliances such as TV, VCR, Heater, Iron, electric kettle, Oven etc. in the rooms are prohibited.
- 5. Pets are not allowed in the hostel complex.

W. REVISION OF RULES AND REGULATIONS

The hostel management reserves the right to revise the rules and regulation from time to time and will keep the hostellers informed of any changes in the form of notices on the hostel notice boards. Ignorance of rules will not be accepted as an excuse.

X. COMPLAINTS AND SUGGESTIONS

Any complaints, suggestions or enquiries are always welcome.

Y. ADDITIONAL HOSTEL RULES FOR GIRL STUDENTS

- Each student shall present herself in the warden room to get herself marked present from 6.00 pm to 7.00 pm daily from Monday to Sunday except for the weekends commencing Friday evening to Monday morning, in case they are going home.
- 2. For leaving from hostel, a slip shall be signed by the Warden putting the date and time of departure. This slip shall be signed by one of the parents after noting down the time and date at which the student reached her home.
- The same slip shall be signed by the parents noting the time and date of leaving from home for the University.
 The slip will be deposited with the Chief Warden/Warden.
- 4. No student shall take a lift from any known or unknown person for going home and returning to the University/hostel. Only public transport or transport provided by SBBSMCS is to be used.
- For emergencies, the parents are requested to take their wards home personally or through a close relative duly authorised in writing and whose photographs are in the hostel record.
- A family photo of a girl student with father, mother, brother, sister, local guardian, etc. duly signed by each member, shall be kept in the records.
- Parent shall sign an affidavit regarding permission in case of they are willing to permit their student daughter to travel under her own arrangements independently from/to hostel.

According to UGC guidelines, the definition of ragging states that any conduct whether by words spoken or written or by an act which has the effect of teasing, treating of handling with rudeness any other student, indulging in rowdy or undisciplined activities which causes or is likely to cause annoyance, hardship or psychological harm or to raise fear or apprehension thereof in a junior student to do any act or perform something which such student will not in the ordinary course and which has the effect of causing or generating a sense of sham or embarrassment so as to adversely affect physique or psyche of a fresher or a junior student.

IMPORTANT INSTRUCTIONS FOR THE STUDENTS

- 1. According to Hon'ble Supreme Court of India, Ragging in Educational Institutions is banned.
- 2. Ragging is a Congnizable Offence.
- 3. Senior Students are advised not to indulge in Ragging.
- Ragging entails heavy fines and/or suspension/expulsion.
- Ragging is an undesirable social offence which is totally banned in the University.
- In case the applicant for admission in the University is found to have indulged in ragging in the
 past or if it is noticed later that he has indulged in ragging, admission may be refused or
 he/she shall be expelled from the University.
- 7. In case of Ragging, please do not keep quiet, report it to the Authorities immediately.
- 8. It is mandatory for the parents to report immediately to the Authorities of the University in case their wards inform them about ragging.

As per the directions of the Hon'ble Supreme Court of India, if any incident of ragging come to the notice of authority, the concerned student shall be given liberty to explain and if his/her explanation is not found satisfactory, the authority would expel him/her from the Institute.
